The Engineering Section of the Department ensure that Section 38 and 104 roads and sewers are designed, approved, and constructed to appropriate adoption standards.

### Key Responsibilities:

1. Advise Land Dept on Technical viability of new sites
2. Assist in the production of layouts and technical report for Land Appraisals; and required working drawings
3. Prepare outline engineering schematics for Land Appraisals
4. Brief and commission site investigations, topographical survey and other assessment reports on land acquired
5. Brief engineering consultants on scope of design
6. Initial negotiations/enquiries with statutory bodies on environmental, drainage, highways and other engineering issues when appraising land

7. Manage initial technical submissions for approval by statutory authorities (e.g. S104, S38, S278)
8. Issue engineering information to Commercial, Construction and Sales departments
9. Fee negotiation and appointment of consultants
10. Obtain planning permissions and other statutory approvals e.g. S104 and S38 Agreements
11. Prepare Sales and Legal information e.g. Conveyance plans and M colours
12. Answer Technical queries
13. POS, S38, S104 adoptions
14. In house Planning supervisors role
15. Liaise with Redrow Commercial on Special Projects
16. Comply with responsibilities as laid down in the Group's Health, Safety and Environment Policy.
17. At all times comply with company policies, procedures and instructions.
